

1. Background

Shahjahanpur Municipal Corporation (NN-SPN) is constituted as an umbrella agency established under the Urban Development Department to supervise diversified road infrastructure projects within the state of Uttar Pradesh. Presently, NN-SPN is managing the implementation, operation and evaluation of CHIEF MINISTER GREEN ROAD INFRASTRUCTURE DEVELOPMENT SCHEME (CMGRIDS) (Urban) / other Construction Schemes.

Urban areas are the growth engines of the country. Uttar Pradesh has the highest number of urban bodies in India. The state is committed to achieve the target of "One Trillion Economy" by the year 2027 by strengthening the basic infrastructure, especially the urban infrastructure and by enhancing "Ease of Doing Business" and "Ease of Living". Roads are the most vital component of urban basic infrastructure. Hence, integrated road network becomes one of the prime components of urban basic infrastructure. Due to increasing urbanization in the State, there is a great need to develop and enhance an integrated road network using innovative technology to reduce the burden of extra vehicles and to bring enhanced mobility.

In urban areas, the development of roads of 45 meters or more width is generally done by the Public Works Department and the development of roads of less than 10 meters width is done by the Finance Commission, Mukhya Mantri Nagar Srujan Yojana (C M NSY) and Pt. Deen Dayal Upadhyaya Nagar Vikas Yojana etc. but there is no dedicated plan for the development of roads between 10 m to 45 m wide , while the roads of the said width are the main routes of urban traffic and economic activities.

Aim of the scheme

Development of Integrated Green Roads -

Development of integrated road with related infrastructure like utility ducts, footpath, green zone, streetlight, bus stop, EV (electric vehicle) charging station, pedestrian infrastructure etc.

Cost effective green road construction with low carbon emissions -

To construct cost effective green roads with less carbon emissions using eco-friendly materials and modern techniques for road construction.

Promoting Urban Mobility -

To ensure that all urban roads have an equitable division of the right of way, promoting non motorized movement with wide, continuous and evenly paved footpaths.

Safe roads and road junctions and intersections -

To reduce road crashes, roads are to developed with advanced road safety measures and technical

facilities for all modes of transport. Complete planning and design of junctions is to be done.

To manage and maintenance of road assets -

Effective and efficient maintenance and management of assets created through interventions, road data bank, road directory and other measures.

Efforts to make the urban bodies financially autonomous-

One of the objectives of CM-GRIDS (Urban) is to encourage urban bodies to increase revenue collection, so that they can be made financially autonomous.

Convergence of various schemes related to road construction-

To integrate with the objectives of the State level integrated schemes (such as SUDM, SUGAM, SAFE CITY or other schemes).

Development of spaces for parking and vending activities -

Along with the development of Integrated Green Roads, parking and parking zones will be developed based on Right of Way (Row) and provide smooth movement of people & vehicles.

2. Expression of Interest

The selected applicant will provide technical and advisory support for the proper execution of integrated road works under CMGRIDS& Other Scheme's etc. Responsibilities include ensuring GFC drawings are issued to as per project sequencing, maintaining design, quality control compliance, and resolving on-site issues if any. Additionally, the applicant will assist Nagar Nigam officials with organizational, professional, and operational requirements of the Nagar Nigam. The detailed Terms of Reference along with the Scope of Works has been provided in Annexure 1.

3. Eligibility

The eligibility of the candidates will be as follows:

1. Diploma /Graduation with first class or minimum 60% marks or higher educational qualification from premier institutes/universities.
2. Should be proficient in speaking and writing Hindi (Devanagari script).
3. Relevant work experience as per Scope of work and subsequently evidence has to be provided.
4. It is mandatory for the candidates to be willing to work in the field work.
5. The max age of the candidate should not exceed 40years as on the last date 30-01-2025

4. Selection Process and Evaluation Criteria

- The Department has adopted a two-stage selection process (collectively the “Selection Process”).
- The application will be scrutinized at Urban Road Infrastructure Development Agency/Nagar Nigam level by a Screening-cum- Selection Committee and candidates will be shortlisted based on their merits.
- The application will be evaluated (out of 70) and candidates will be short listed on the basis of appropriate marking system, The categories for marking and their respective marks are as under:

- For the interview process, candidates will be shortlisted who score a minimum of 50 marks out of total 70 marks based on profile assessment.
- Interview marks will be in addition to the profile assessment marks (max 30 marks)
- The final recommendation of the Selection Committee shall be final and no further correspondence

will be entertained in this regard.

- The number of vacancies may be reduced, if suitable candidates are not available.

5. Submission of Application

7. Confidentiality

The Information relating to evaluation of the application and recommendations concerning awards shall not be disclosed to the Applicant, who has submitted the application or to other persons not officially concerned with the process.

8. Termination of Contract

Shahjahanpur Municipal Corporation, if not satisfied with the work performance of the appointed Civil Engineer, may terminate the Contract with 30 days’ notice in advance. If the candidate decides to resign then he/she should give at least a month’s advance notice to the Shahjahanpur Municipal Corporation.

9. Payment Terms & Condition

- a. The selected candidate i.e. Civil Engineer will be given fixed monthly remuneration by Shahjahanpur Municipal Corporation.
- b. TDS and other statutory deductions to be done as per prevailing Government norms.
- c. In house infrastructure facility for office space/ furniture/ office equipment's/ office supplies will be provided to the selected applicant.
- d. Payment will be made only through RTGS/NEFT electronic transfer.
- e. Payment will be made only after the Civil Engineer raises an invoice for the previous month along with attendance sheet addressed to the Chief Engineer/Executive Engineer of the Shahjahanpur Nagar Nigam and the latter approves the attendance sheet and invoice for release of payment.
- f. Payment will be made within 20 days after receiving the invoice for each month.

10. Tenure of Engagement

- a. The contract will be for **one year**.
- b. On completion of initial term of one year, the engagement contract may be extended further on an annual basis based on the satisfactory performance of the candidate subject to a maximum total engagement duration of 3 years.
- c. Either party may terminate the engagement by giving a mandatory minimum of 30 days' notice to the other party.
- d. The contractual services are liable for termination at any time before the expiry of the contract period due to poor performance or misconduct, as per requirement, by serving 30 days' written notice.
- e. The appointment is only for the contract period and the candidate will not have any lien to the Department in any manner after the end of the contract period.

The scheme is designed to ensure the quality and timely execution of road infrastructure projects. Scope of work

1. The Civil Engineer must execute the work strictly according to the directions provided by Shahjahanpur Municipal Corporation and in compliance with the applicable rules and regulations in force.
2. Without limiting the scope, the candidate must work in close liaison with Shahjahanpur Municipal Corporation and will be responsible for the following tasks
 - a. **Adhere to Guidelines**
 - i. Thoroughly familiarize yourself with and comprehend the design guidelines, branding guidelines, and mandatory requirements and with other best practices, such as Tender S.U.R.E.
 - b. **Checking of Good for Construction (GFC) Drawings:**
 - i. Ensuring that Good For Construction (GFC) drawings are issued accurately and timely by Nagar Nigam (consultant) to the contractors.
 - ii. Confirming that the GFC drawings are aligned with the approved project sequence and incorporate all necessary provisions and revisions.
 - c. **Design Compliance on Site:**
 - i. Ensure that all construction activities adhere to the approved design and specifications.
 - ii. Conduct regular site inspections to verify compliance with design standards.
 - iii. Address any deviations from the design promptly with Shahjahanpur Municipal Corporation and implement corrective measures suggested by Shahjahanpur Municipal Corporation.
 - d. **Quantity measurement and BOQ verification**
 - i. Keep track of materials consumed and verify contractor BOQ as first point of on-site contact.
 - ii. Highlight any deviations and escalations to Shahjahanpur Municipal Corporation promptly.
 - e. **Quality Control and Inspections:**
 - i. Implement quality control measures to ensure that construction work meets the required standards and specifications.
 - ii. Conduct regular quality audits and inspections to identify defects and address them with Shahjahanpur Municipal Corporation and rectify them accordingly.
